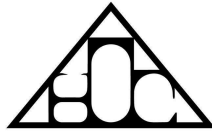

§1. Membership

Your membership is personal. Thus, it cannot be transferred to, shared with or used by others. Changes to personal data eg. name, address, e-mail, phone number, bank information etc. you are pleased to inform House of Concrete Aalborg by mail kontakt@houseofconcrete.dk. It is also your responsibility to fill out this information clearly and correctly on this form. An association contingent is required to purchase a training membership.

The membership is binding for both parties within the period specified in the contract. House of Concrete Aalborg can ask to see a photo ID.

The association contingent gives membership to House of Concrete Aalborg for one year and includes the chosen training membership the month of enrollment (that is, you don't pay for the training membership for the month of enrollment, only the association contingent). Therefore, the month you enroll will always cost you 250 dkk, no matter what training membership you choose (this applies for any date you enroll during the month, but only once). The training membership is to be paid monthly by the 1st of the following month. Having a training membership allows you to take a friend and let them into House of Concrete on your member card to train freely for a whole day. However, the friend needs to pay a fee of 99 dkk to use the facilities. When you have a membership in House of Concrete Aalborg the membership has to be paid until an eventual resignation, even if the membership hasn't been in use.

§2. Member cards

The price for a door card is included in the association

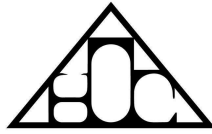
contingent. At your first training the member card will lie ready for you on the table in the reception. If your member card isn't there, it is your responsibility to contact us by mail

kontakt@houseofconcrete.dk and inform us that your card is missing. The card is personal and can't be transferred to or used by others. If the card gets lost or damaged it should be reported to House of Concrete Aalborg and a new card will be issued for a fee of 100 dkk. If you have an old card it can be reactivated.

§3. Payment

To be a member of House of Concrete Aalborg you need to pay an association contingent of 250 dkk at enrollment, which is subsequently charged annually. After that, your ongoing training membership is paid via bank transfer the 1st of every month. If you do not pay your association contingent at the annual charge, you are no longer a member of the association and your training membership is terminated immediately. You are responsible for the payment to happen on time. Non-timely payment is equated with breach of contract.

By signing this contract, you consent that House of Concrete Aalborg can store personal information. If, for example, the contract is breached by missing payment, House of Concrete Aalborg reserves the right to disclose your personal information with third parties. By memberships with another payer, the payer, in addition to fixed monthly expenses, will automatically also be liable for additional expenses and fees incurring as a result of the membership.



§4. Late payment

If your current training membership is not paid by the 7th of the month, a reminder letter will be sent to you and a reminder fee will be charged at the current rate of 100 dkk. If you do not pay within 10 business days of the due date, your membership card will be blocked until the balance is settled. The exclusion period is not credited by House of Concrete Aalborg. House of Concrete Aalborg reserves the right to collect the amount owed through a lawyer or debt collection company, as well as to report bad payers to RKI (Riber Kredit Information). The membership will only be reactivated once the amount owed has been paid and the member has provided evidence that the amount owed has been paid. In addition, a member who has received three reminders will not be able to join House of Concrete Aalborg at a later date or participate in activities organized by House of Concrete Aalborg.

§5. Duration of membership

This is an ongoing training membership that will continue until terminated by one of the parties under §6. For whatever reason, no full or partial reimbursement of prepaid memberships is provided.

§6. Termination of membership

Termination notice for training membership is current month plus 1 month. The termination must happen in writing to House of Concrete Aalborg by mail kontakt@houseofconcrete.dk. Upon termination, full name and membership number are provided. In addition, it is the member's responsibility to save a copy of the dated termination so that in case of doubt it can be presented as evidence that a correct termination has been made. The same rules apply when downgrading the membership. The association contingent is not refunded.

§7. Disputes and documentation

If there is any doubt as to whether a membership has been terminated, the member must be able to prove that a correct termination has been made by proving the date of termination, as well as a copy of confirmation of termination from House of Concrete Aalborg. This the member will have received by mail immediately upon termination. It is the member's responsibility to ensure that they have received a copy of the notice of termination correctly.

It is the member's responsibility that House of Concrete Aalborg has the correct contact information at all times, including correct e-mail, telephone number and address.

§8. Right of withdrawal of membership

At the start date of membership, the membership is considered to be in use and the right of withdrawal is waived.

§9. Changes to price and membership conditions

House of Concrete Aalborg reserves the right to change prices. Price changes will be notified by email no later than 45 days before the price change takes effect

§10. Training and stay in the facility

All training and stays in House of Concrete Aalborg is at your own risk. This applies to both members and guests. Young people between the ages of 8 and 18 as well as those who are legally incompetent are only allowed to use the facilities of House of Concrete Aalborg, if House of Concrete Aalborg has received written permission from the parents or legal guardian. Children under 15 are not allowed to stay in the training areas without an adult. During training, clothing and shoes intended for indoor training must always be worn, and mobile phones may not be used during classes unless the instructor has given explicit permission.

Racist or condescending statements cause immediate expulsion.

§11 Children and family in the facility

Children and adolescents (persons under 15 years of age) may not, for safety reasons, stay unattended by an instructor in the training area or classroom. In addition, parents and other families may only reside in the center's chill area while child and youth teams are run and may not reside at the center at other times. Coffee and other things in the chill area are reserved for members of the association.

§12. Breach of contract

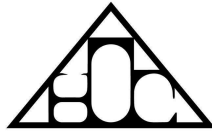
Both members and guests commit to comply with the prescribed conditions for stay and use of tools etc., including compliance with the rules of procedure and references from the staff. Lack of this constitutes a substantial breach of contract. If a member is threatening or otherwise bothering other members or House of Concrete Aalborg employees, House of Concrete Aalborg may expel the member without notice and the membership will terminate immediately. This also applies to serious violations of membership conditions, such as, for example, doping or lending of membership cards.

§13. Changes to classes etc.

House of Concrete Aalborg reserves the right to make changes to opening hours, class schedules, class hours, instructors and team offerings by posting in the House of Concrete Aalborg internal Facebook group 'HoC Medlemmer'. In addition, House of Concrete Aalborg can cancel a class or change the instructor/class type on the same day no later than 1 hour before the scheduled class start.

§14. Health condition and personal injury

All training is done at your own risk. You are responsible for being in the state of health that allows participation in activities at House of Concrete Aalborg. House of Concrete Aalborg accepts no liability for personal injury to a member as a result of accidents, incorrect training or other visitors' actions or defective actions. Improper training is considered training that contradicts the instructor's or association board's safety instructions. There is no guarantee of weight loss.



§15. Valuables

It is recommended that no items of value are stored in the wardrobe. House of Concrete Aalborg bears no responsibility for loss due to theft or property damage, nor by theft from cabinets.

§16. Personal data/Information/News

Upon enrollment you authorize House of Concrete Aalborg to process and store information about you and contact you by phone and can regularly send news and information by e-mail and SMS. This service may be opted out by written notice to House of Concrete Aalborg, however, House of Concrete Aalborg reserves the right to submit important information regarding memberships and changes via e-mail. §17. Cancellation of classes

If you need to cancel your attendance for a class, it must be done no later than 4 hours before the class start. Also, remember to remove yourself from the waiting list within the same deadlines if you no longer wish to join the class. If you forget to cancel, a fee of 55 kr. is charged. If you fail to pay a fee in case of late cancellation, the same rules apply as in §4.

§18. Attendance

Attendance for all classes must happen at latest 5 minutes before class start. Attendance for private lessons must happen 30 minutes before the time of appointment and the attendee must be warm for the given starting time.

§19. Waiting list

Remember to remove yourself from the waiting list if you no longer wish to join a class. If you get a spot but do not want to participate, it will be considered late cancellation. Same rules apply as in §17.

§20. Cancellation of private lessons/personal trainer

If you are unable to comply with an appointment with our personal trainer, we ask you to cancel the day before, before 4 pm (16.00). If you forget to cancel, you will still have to pay the full amount and the amount will not be refunded at a later date.

§21 Photos and video on the facilities

House of Concrete Aalborg reserves the right to take photos and video on the facilities for marketing or other material, unless otherwise agreed on in writing.

§22 Consent

By signing below, you acknowledge that you have read and understood the terms of membership.
